1. Resignation of Statutory Auditor of the Company

This is to inform you that the Statutory Auditor of the Company, M/s. T R Chadha & Co LLP, Chartered Accountants, ICAI Firm Registration No. (006711N/N500028) have resigned from the position of the Statutory Auditor of the Company with effect from 5th November, 2025 i.e., post submission of Limited Review Report for the quarter and half-year ended 30 September 2025 and after furnishing all requisite certifications for the aforesaid audit/limited review period.

The reason cited by them for their resignation is that, based on their understanding, as a part of Adani Group, the Management is considering to align its process for appointment of statutory auditors wherein audit of major listed companies of the group is to be conducted by globally affiliated firms.
