4. In case any information submitted by the Bidder is found to be false, forged or incorrect at any time during process for evaluation of tenders, the Bid shall be rejected and the Bid Security shall be liable to be forfeited.
5. Bid validity is 90 days beyond the bid submission date.
6. Open Competitive Bidding will be conducted in accordance with ADB's Single-Stage Two-Envelope bidding procedure and is open only to Bidders from India, as described in the Tender Documents.
7. Bidders are advised to visit the Project Office of Cemindia Projects Ltd., **CMRL Projects, UG01 & UG02, Chennai Light House, Chennai – 600 005,** and the Project Site to acquaint themselves with the site conditions, accessibility, working environment, constraints, and the expected quantum and nature of the Works before submitting their Bids.
8. Delivery of Bidding Document and Bid Security:
 - (a) The Tender Documents may be obtained from the Project Office during the period from **17th July 2026 to 30th July 2026 on all working days between 10:00 Hrs. and 18:00 Hrs. (IST)** or may be issued electronically upon receipt of a written request from an interested Bidder.
 - (b) Submission of **Bid in Originals** along with the Bid Security in case of Bank Guarantee / Demand Draft (in originals) shall be accepted up to **15:00 Hrs. on 06th August 2026** at the project office of **Cemindia Projects Ltd. by hand or by post at the address mentioned above in para.7.** Postal delay will not be accepted by Cemindia Projects Ltd.
 - (c) In case of RTGS/NEFT/SWIFT transactions, bidders shall submit the copies of transaction of payment along with the Original Copy of Bid at the time of submission of bid at the address mentioned above in para.7 and as mentioned in ITB.
9. The prescribed Bid Security, as mentioned above, is to be deposited along with the Technical Bid.
10. The date and time of opening may be postponed at the sole discretion of Cemindia Projects Ltd., if circumstances so warrant.
11. (a) Cemindia Projects Ltd. reserves its right to either cancel the Bid or reject any or all the Bids without assigning any reason thereof.
 (b) The Tender Documents may be obtained by any interested Bidder satisfying the Eligibility and Qualification Criteria specified in Section II – Evaluation and Qualification Criteria from the Project Office of Cemindia Projects Limited (as mentioned in para.7 above) at Chennai.
 (c) Only those Bidders who meet the Eligibility and Qualification Criteria specified in Section II – Evaluation and Qualification Criteria of the Tender Documents shall be considered for further evaluation. Bidders are advised to satisfy themselves that they comply with all such requirements before submitting their Bids.
12. The Last date for seeking pre-bid clarifications: **24th July 2026** upto 18:00 Hrs. Last date for issuing the addendum is **30th July 2026** upto 18:00 Hrs.
13. **Technical bids** will be opened on **06th August 2026 at 15:30 Hrs. (IST)** in the project office of Cemindia Projects Ltd. in the presence of Bidders' representatives who choose to attend, whereas the Financial Bids shall remain unopened. The Financial Bids of only Technically Responsive and Qualified Bidders shall be opened after Technical Bid

Evaluation, whereas the Financial Bids of those Bidders whose Technical Bids are not responsive and qualified shall be returned unopened.
